FAR NOTICE OF SECURITIES APPLICATION

The Florida Public Service Commission will consider at its October 4, 2022 Agenda Conference, Docket No. 20210153-EI, Application for authority to issue and sell securities for 12 months ending December 31, 2022, by Tampa Electric Company (Company). The Company seeks PSC approval pursuant to Section 366.04, Florida Statutes, to amend its authority to issue and sell securities.

DATE AND TIME: Tuesday, October 4, 2022. The Agenda Conference begins at 9:30 a.m., although the time at which this item will be heard cannot be determined at this time.

PLACE: Commission Hearing Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida 32301.

PURPOSE: To take final action in Docket No. 20210153-EI in order to amend the Company's short-term borrowing authority for 2022 from \$1 billion to \$2.2 billion. This would constitute a modification of the authority granted to the Company in Order No. PSC-2021-0414-FOF-EI, issued November 5, 2021, as modified by Order No. Psc-2022-0114-FOF-EL, issued March 15, 2022.
