The purpose of this prehearing conference is to: (1) simplify the issues; (2) identify the positions of the parties on the issues; (3) consider the possibility of obtaining admissions of fact and of documents which will avoid unnecessary proof; (4) identify exhibits; (5) establish an order of witnesses; and (6) consider such other matters as may aid in the disposition of the action.

November 2, 2022 and November 3, 2022, have also been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

PURPOSE AND PROCEDURE:

The purpose of this hearing shall be to receive testimony and exhibits relative to issues and subjects, including but not limited to, the following:

- 1. Determination of the Projected Levelized Fuel Adjustment Factors for all investor-owned electric utilities for the period January 2023 through December 2023;
- 2. Determination of the Estimated Fuel Adjustment True-Up Amounts for all investor-owned electric utilities for the period January 2022 through December 2022;

- 3. Determination of the Final Fuel Adjustment True-Up Amounts for all investor-owned electric utilities for the period January 2021 through December 2021, which are to be based on actual data for that period;
- 4. Determination of Generating Performance Incentive Factor Targets and Ranges for the period January 2023 through December 2023;
- 5. Determination of Generating Performance Incentive Factor Rewards and Penalties for the period January 2021 through December 2021;
- 6. Determination of the Projected Capacity Cost Recovery Factors for the period January 2023 through December 2023, including nuclear costs;
- 7. Determination of the Estimated Capacity Cost Recovery True-Up Amounts for the period January 2022 through December 2022, including nuclear costs;
- 8. Determination of the Final Capacity Cost Recovery True-Up Amounts for the period January 2021 through December 2021, which are to be based on actual data for that period;
- 9. Determination of the Projected Conservation Cost Recovery Factors for certain investorowned electric and gas utilities for the period January 2022 through December 2022;
- 10. Determination of Conservation Actual/Estimated True-Up Amounts for certain investorowned electric and gas utilities for the period January 2021 through December 2021;
- 11. Determination of the Final Conservation True-Up Amounts for the period January 2020 through December 2020 for certain investor-owned electric and gas utilities, which are to be based on actual data for that period;
- 12. Determination of the projected Purchased Gas Adjustment Cost Recovery Factors for the period January 2023 through December 2023;
- 13. Determination of Actual/Estimated Purchased Gas True-Up Amounts for the period January 2022 through December 2022;
- 14. Determination of the Final Purchased Gas True-Up Amounts for the period January 2021 through December 2021, which are to be based on actual date for that period;

- 15. Determination of the Projected Environmental Cost Recovery Factors for the period January 2023 through December 2023;
- 16. Determination of the Actual/Estimated Environmental Cost Recovery True-Up Amounts for the period January 2022 through December 2022;
- 17. Determination of the Final Environmental Cost Recovery True-Up Amounts for the period January 2021 through December 2021, which are to be based on actual data for that period;
- 18. Determination of the final Storm Protection Plan jurisdictional cost recovery true-up amounts for the period January 2021 through December 2021;
- 19. Determination of the actual/estimated Storm Protection Plan jurisdictional cost recovery true-up amounts for the period January 2022 through December 2022;
- 20. Determination of the projected Storm Protection Plan jurisdictional cost recovery amounts for the period January 2023 through December 2023; and
- 21. Determination of the Storm Protection Plan total jurisdictional cost recovery amounts to be included in establishing Storm Protection Plan cost recovery factors for the period January 2023 through December 2023.

The purpose of this hearing is to consider any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on Wednesday, October 19, 2022. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
