LEWIS: Greetings, Commissioners. 5 Item 9 is a combined recommendation for the transfer of River Grove Utilities, Incorporated, to 6 7 Cobblestone II RVG, LLC, for the deletion of part 8 of the service territory. 9 The utility provides water and wastewater 10 service to approximately 179 residential customers 11 in Brevard County. The property requested to be 12 deleted contains two single family residences was 13 additional undeveloped acreage.
