A modification is required to Issue 2 to correct for a number transposition error. For Issue 9, a modification is required to remove estimated interest amounts from the recommendation statement. The interest amounts are subject to change and the actual interest amounts recovered will ultimately be handled in the true-up filing discussed in Issue 13.

In addition to these costs, Gulf should be allowed to recover \$0.311 million and \$0.001 million in interest on the unamortized storm restoration costs for Hurricane Sally and Hurricane Zeta, respectively.

Issue 9, Page 44, Second Sentence in Conclusion Paragraph

In addition to these costs, Gulf should be allowed to recover ~~\$0.311 million and \$0.001 million in~~ interest on the unamortized storm restoration costs for Hurricane Sally and Hurricane Zeta, ~~respectively~~.
