Dear Ms. Watts:

This letter and its exhibits are submitted as an amendment to the application originally filed in this docket on November 28, 2022. This docket was opened to request a quick-take extension of the water and wastewater territories, Water Certificate 405-W and Wastewater Certificate 342-S. Through subsequent investigation of the territory with your assistance, it was determined that a deletion to the wastewater territory was also needed, to delete the site of Tradewinds' former wastewater treatment plant, which was recently transferred to Marion County. Tradewinds continues to provide wastewater service through a bulk services agreement with Marion County. Accordingly, Tradewinds requests deletion of that portion of its wastewater territory. With this letter, Tradewinds also provides updated legal descriptions and maps clarifying the territory to be added, deleted and the resulting territory of the water and wastewater systems. Tradewinds Utilities, Inc. submits the following additional information in support of this request:

Territory Description, Maps, Facilities, and Technical Ability

Tradewinds Utilities, Inc. is not planning to build a new water or wastewater treatment plant or other facilities to serve the extension territory.

Exhibit G¹ contains legal descriptions of the proposed extension area and complete resulting territory of the WATER system territory in the format prescribed in Rule 25-30.029,

EXHIBIT IWATER - Map of the existing territory and proposed extension areas




EXHIBIT JWATER - Map of the Resulting Territory



WASTEWATER – Map of the existing territory and proposed extension and deletion areas




EXHIBIT LWASTEWATER - Map of the Resulting Territory


