On behalf of CSWR-Florida Utility Operating Company, LLC (“CSWR-Florida UOC”), the following are the company’s responses to the Commission’s January 11, 2023 deficiency letter:

- 1. Seller Information.** Rule 25-30.037(2)(c), F.A.C., requires the applicant provide the certificated name, address, telephone number, certificate number(s), authorized representative, and, if available, email address and fax number of the utility/seller. The Seller’s fax number does not match the Florida Public Service Commission’s (Commission) records. If the information provided in CSWR-FL’s application is correct, please have the Seller update its information with the Clerk’s Office by filling out and submitting the Change of Regulated Utility Contact Information form under the Clerk’s Office tab on the Commission’s website, [www.floridapsc.com](http://www.floridapsc.com). Otherwise, please provide the correct information for this Utility.
