On January 10, 2023, the Commission voted to deny your petition to waive Rule 25-30.020(2)(f), Florida Administrative Code, which pertains to the filing fees required for processing your application for a limited alternative rate increase (LARI). In addition, FUS1 has filed an amendment to the application to include Leighton Estates Utilities, LLC (Leighton). You were previously advised that the filing fee for the application is \$13,000. With the addition of Leighton, the filing fee requirement is now \$13,500. Please submit the filing fee on or before February 9, 2023. The official filing date will be the date the filing fee is paid. If the filing fee is not paid within that timeframe, the application will be deemed denied.
