(My daughter and son-in-law get no bill, and they have fewer panels than I have.) My "minimum bill" was \$9.99, then \$10.05, and it stayed that way every month, all year, for two years, until last year. Then, it was suddenly \$30.17 -- three times the unwavering "minimum bill." The reason FPL can charge a minimum bill, and increase it, is that the PSC allows it to do that. And the PSC is appointed by electeds who receive campaign contributions from, and are beholden to, and owned by FPL.

FPL is not motivated to improve efficiency, or find renewable ways to create electric power. All they have to do is ask the PSC for permission to charge more, and the PSC will give them the permission they request. The other possibility, of course, is that so many people get solar panels that FPL will go out of business, because hardly anyone will have to buy electricity from them. Like when the horse industry went out of business, because people started driving cars. And the brick and mortar arrangement is suffering, because people prefer to buy things online. That's life. Normally, a company or an industry, if they want to stay in business, will have to find ways to compete. FPL doesn't have to find ways to compete. They have you to protect them.
