# PEOPLES GAS SYSTEM, INC.'S REQUEST FOR CONFIDENTIAL CLASSIFICATION

Peoples Gas System, Inc. ("Peoples" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, hereby requests confidential classification for certain information contained in the company's response to Florida Public Service Commission ("Commission") Staff's first data request. In support thereof, Peoples states:

#### **Background**

- 1. On December 15, 2022, Peoples filed a Petition for Approval of Depreciation Rate and Subaccount for Renewable Natural Gas Facilities Leased to Others ("Petition"), which established the above-captioned docket. *See* DN 12024-2022.
- 2. In the Petition, Peoples explained that the request for a new depreciation rate and subaccount was prompted by the company's participation in a new renewable natural gas ("RNG") project. Paragraph 20 of the Petition explained that that the RNG project is governed by a series of agreements between Peoples and Brightmark Sobek RNG, LLC ("Project Agreements").
- 3. On February 2, 2023, Commission Staff served Peoples with Staff's First Data Request. *See* DN00830-2023.
- 4. Staff's First Data Request No. 7 asks Peoples to produce the agreements referred to Paragraph 20 of the Petition (*i.e.*, the Project Agreements). As explained herein, Peoples seeks confidential classification of certain information included in these agreements.

#### Request

- 5. Subsection 366.093(1), Florida Statutes, provides that any records "found by the Commission to be proprietary confidential business information shall be kept confidential and exempt from s. 119.07(1), Florida Statutes requiring disclosure under the Public Records Act.]"
- 6. Proprietary confidential business information includes, but is not limited to: "information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods and service on favorable terms" and "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." §366.093(3)(d)-(e), Fla. Stat.
- 7. The confidential information that is the subject of this request falls within these statutory categories and thus constitutes proprietary confidential business information entitled to protection under Section 366.093, Florida Statutes and Rule 25-22.006, Florida Administrative Code.
- 8. Attached hereto as Exhibit A is a justification for confidential treatment of the confidential information contained in the Project Agreements.
- 9. Public versions of the documents with the confidential information redacted were previously produced as part of the company's responses to Staff's First Data Request.
- 10. The confidential information in the Project Agreements is intended to be and is treated by Peoples as confidential and has not been publicly disclosed.
- 11. Pursuant to Rule 25-22.006(9)(a), Peoples requests that the confidential information be treated by the Commission as proprietary confidential business information for 18 months.

WHEREFORE, Peoples respectfully requests that the confidential information that is the subject of this request be accorded confidential classification for the reasons set forth herein for 18 months.

- (1) This highlighted information consists of negotiated, non-standard contractual terms such as pricing, scope of work, or the rights and obligations of the signatories. This constitutes "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility to contract for goods or services on favorable terms." §366.093(3)(d), Fla. Stat. It also constitutes "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." §366.093(e), Fla. Stat. This information is accordingly entitled to confidential protection pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code.
- (2) Pursuant to the Project Agreements, Brightmark will construct facilities to collect and condition biogas. The highlighted information consists of project layout, design, and/or engineering information; the identities of contractors engaged to develop various aspects of the project; and/or information describing the project equipment. Public disclosure of the project design and scope information could impair the ability of Peoples to enter into similar contracts with RNG project developers in the future. Public disclosure would also impair Birthmark's competitive business interests by making their RNG facility designs and development process public. This information thus constitutes "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility to contract for goods or services on favorable terms." §366.093(3)(d), Fla. Stat. It also constitutes "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." §366.093(e), Fla. Stat. This information is accordingly entitled to confidential protection pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code.
