Message: Good morning -

I am reaching out to schedule a time when the commissioner could meet with us to discuss the utility rate hikes in Hillsborough County. Food & Water Watch is a national advocacy organization and we represent 5,433 Hillsborough County member residents. Last year, Hillsborough County's main energy utility, Tampa Electric (TECO), was approved for two separate rate hikes of 31% each. TECO continues to ask for rate hikes to help pay for their dirty energy projects, including converting the state's largest coal plant to gas, pipeline expansions and a carbon capture scam project. Rates have risen from \$99/mo to nearly \$162/mo for the average ratepayer in just the past 4 year. The Florida Public Service Commission has become a rubber stamp for these rate requests, so we will continue to see rates soar.

We are part of a larger coalition of organizations pushing back on the root causes of these hikes and would love to meet with you to discuss what Hillsborough County can do to help. Please let us know when you are available for a meeting.

Hillsborough County Commissioner Harry Cohen forwarded your concerns about Tampa Electric Company (TECO) to the Florida Public Service Commission (FPSC). The FPSC regulates investor-owned electric, and natural gas utilities throughout the state, and investor-owned water and wastewater utilities in those counties which have opted to transfer jurisdiction to the FPSC. The FPSC has authority in the telephone industry which is limited to the Lifeline Assistance Program, Florida Relay Service, and pay telephone service. We appreciate the opportunity to respond directly to you.

You expressed a concern about recent rate increases. On March 7, 2023, the FPSC approved TECO's charges, including the new fuel factor and the preliminary approval for recovery of \$131 million in interim storm restoration costs associated with Hurricanes Dorian, Elsa, Ian, Nicole, and Tropical Storms Alberto, Nestor, and Eta.

Utilities do not earn a profit on fuel charges. The fuel and capacity cost component of customers' bills is set for each calendar year, but mid-course corrections are used when a utility's costs increase or decrease significantly in the interim. Under Commission rules, a utility must notify the PSC when it expects an under- or over-recovery greater than 10 percent.

We appreciate you sharing your views and will add your correspondence to both Dockets 20230001 and 20230019 regarding the mid-course correction and the storm restoration recovery, respectively.

You may review all the information filed for Commission consideration in the above dockets by accessing the FPSC website at http://www.floridapsc.com. Under the Clerk's Office tab at the top of the page, click on Dockets. Type in each docket number. Click the Search button. Then select Document Filings Index for a list of all filings in the docket. This procedure allows you to view all of the information filed by the utility and other parties in the docket.
