Dear Mr. Martin:

The Governor's office forwarded a copy of your email regarding Duke Energy Florida (DEF) to the Florida Public Service Commission (FPSC). The FPSC regulates investor-owned electric, and natural gas utilities throughout the state, and investor-owned water and wastewater utilities in those counties which have opted to transfer jurisdiction to the FPSC. The FPSC has authority in the telephone industry which is limited to the Lifeline Assistance Program, Florida Relay Service, and pay telephone service. We appreciate the opportunity to respond directly to you.

You expressed a concern about recent rate increases. On March 7, 2023, the FPSC approved a mid-course correction to the fuel factors and granted preliminary interim storm restoration charge for DEF.

The adjusted fuel factors reflect unrecovered fuel costs incurred in 2022. The interim storm restoration recovery charges are costs associated with named storms and will replenish each utility's storm reserve fund. Interim storm restoration charges are approved for a 12-month recovery period and are subject to refund, with interest, pending further review once the total actual costs are known for each utility.

DEF's approved charges include the new fuel factor to be recovered over 21 months and the preliminary approval for recovery of \$442.1 million in interim storm restoration costs for Hurricanes Elsa, Eta, Ian, Isaias, and Nicole, and Tropical Storm Fred.

We appreciate you sharing your views and will add your correspondence to both Dockets 20230001 and 20230020 regarding the mid-course correction and the storm restoration recovery, respectively.

Dear Ms. Plendl

To start I would like to say "Thank you" for your rapid response to my inquiry into the rate increase by Duke Energy of Florida (DEF).

I totally understand the need of DEF to make up for the increased fuel cost in 2022. That was an extraordinary year for the inflation of fuel prices for both their power plant operation and gasoline for the repair trucks on the street. We have all felt it!! And don't like it at all!!

Gas prices peaked in 2022 at a national average of \$3.42 up about 15 % from year end 2021.

LNG also peaked in 2022 due to restraints by the Federal Government on LNG production and increased demand of exported LNG. The Henry Hub natural gas spot price peaked around \$9.85/MMBtu. 60% higher than the beginning of the year. However by year end it was close to the previous 5 year average at \$3.46/MMBtu.

I don't know how much DEF relies on LNG to fire their electric generation, vs. oil and solar and nuclear.

I also don't know what audit was performed by FPSC to ascertain the legitimacy of the cost increases that DEF is claiming. But given some of the information that I have been able to read about, a 20% increase seems extraordinary.

The other part of your response spoke about recovery of \$442.1 million in interim storm restoration costs for hurricanes.

If you put the storms mentioned in your letter in chronological order, we see the following:

How is it their Florida Customers are still making up for restoration costs going back to August of 2020? And for storms that barely reached hurricane strength!! Are they gilding the lily with data overload? Do they carry insurance coverage against catastrophic occurrences?

This is not the first rate increase we have had since then.

Again I must ask, did FPSC audit and validate the costs they are claiming?

The bottom line is that I find the 20% increase to be very exorbitant, especially for us senior retired folk on fixed incomes. I respectfully request that you revisit these approvals of rate increases allowed to Duke Energy of Florida.

Thank you once again for your response to my inquiry.
