6 CHAIRMAN FAY: All right. Good morning,
7 everyone. We will call this April 4th Agenda
8 Conference to order.

9 Commissioners, this morning, we will be taking
10 up Items 1 and 3 through 8 in the normal process,
11 and then Item 2, we will move to the end for
12 further discussion.

13 Commissioners, any other items that we would
14 want to move for further discussion at this time?

15 Seeing none, then we will move into our first
16 item this morning to be presented by
17 Ms. Sapoznikoff. You are recognized.

18 MS. SAPOZNIKOFF: Thank you. Good morning,
19 Commissioners. I am Susan Sapoznikoff with the
20 Office of General Counsel.

21 In Item 1, staff recommends the amendment of
22 three water and wastewater rules related to staff
23 assistance with rate setting. The proposed
24 amendments are to comply with the statutory mandate
25 to adjust the gross revenue limits every five years

1 based on the most recent cumulative five years of
2 price index established by the Commission.

3 In specific, the proposed amendments increase
4 the gross annual operating revenue eligibility
5 limit from \$300,000 or less to 335,000 -- \$335,000
6 or less to -- per system type, or from \$600,000 or
7 less to \$670,000 or less if a combined basis is
8 allowed.

9 Staff is available to answer any questions.
10 Thank you.

11 CHAIRMAN FAY: Great. Thank you for the
12 summary on Item No. 1.

13 Commissioners, we will take up any questions
14 or comments on the item at this time. And seeing
15 none, we will take up Item 1 motion.

16 COMMISSIONER CLARK: Move staff
17 recommendation, Mr. Chairman.

18 COMMISSIONER GRAHAM: Second.

19 CHAIRMAN FAY: Okay. We have a motion and a
