Dear Ms. Sapoznikoff:

I have reviewed the above-referenced proposed rules, which were advertised in the Florida Administrative Register on April 6, 2023. I have the following comments for your consideration and response:

25-30.455: Section 367.0814, F.S., requires the Commission to adjust the gross annual revenue level for utilization of staff assisted rate cases specifically on July 1st of every 5 years following July 1, 2013. As the Commission is seeking to accomplish this requirement through the updates to this rule, it appears that a delayed effective date will be necessary to accomplish this directive. Section 120.54(3)(e)6., F.S., requires notice of a delayed effective date to be included in the proposed rule notice. As this was not done for this rule, it appears that a Notice of Change is necessary to set forth this required effective date.


