STAFF'S MOTION TO MODIFY ORDER ESTABLISHING PROCEDURE

The staff of the Florida Public Service Commission, by and through its undersigned counsel and pursuant to Rule 28-106.204, Florida Administrative Code (F.A.C.), files this Motion to Modify Order Establishing Procedure (Motion) to extend the time for Commission staff to file staff testimony and exhibits and in support thereof states:

1. Commission staff is currently auditing the utilities' requests for cost recovery in this docket. Commission staff anticipates filing these audits and any accompanying staff testimony for inclusion in the record at the final hearing in this docket. The revised Order Establishing Procedure (OEP) issued March 20, 2023, in this docket set July 7, 2023, as the deadline for Commission staff to prefile any such testimony and exhibits. The revised OEP also set July 24, 2023, as the deadline for parties to prefile any rebuttal testimony and exhibits.

2. Due to workload constraints, Commission staff will be unable to complete its audits prior to the established deadline for staff to prefile testimony related to those audits.

3. To accommodate this delay, Commission staff requests that the OEP be modified to extend the due date for staff testimony and exhibits from July 7 to July 12, 2023. To afford the utilities sufficient time to review and address the audits and testimony, Commission staff requests that the date for rebuttal testimony and exhibits be extended for two days from July 24 to July 26, 2023.

4. Pursuant to Rule 28-106.204(3), F.A.C., Commission staff contacted all parties to determine if the parties had any objections to the motion. No parties objected.

WHEREFORE, Commission staff hereby requests that the Prehearing Officer grant its Motion to Modify Order Establishing Procedure, extend the due date for staff testimony and exhibits from July 7 to July 12, 2023, extend the due date for rebuttal testimony and exhibits from July 24 to July 26, 2023, and grant such other relief consistent with the Motion as may be just and fair.
