TO REQUEST CONFIDENTIAL CLASSIFICATION**

Peoples Gas System, Inc. ("Peoples" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(3)(a), Florida Administrative Code, hereby files this Notice of Withdrawal of its Intent to Request Confidential Classification for portions of the Office of Public Counsel's ("OPC") response to Peoples Gas System, Inc.'s First Request for Production of Documents (Nos 1-7) served on June 26, 2023.

1. On June 26, 2023, the OPC filed its discovery responses to Peoples' First Request for Production of Documents. Based on informal discussions with the OPC, Peoples understood that portions of the responses contained confidential information previously provided to the OPC through Motions for Temporary Protective Order or Requests for Confidential Classification filed in the above-captioned dockets.

2. On June 27, 2023, Peoples filed a Notice of Intent to Request Confidential Classification for portions of OPC's responses filed on June 26, 2023. *See* DN 03831-2023. Peoples has since reviewed OPC's responses and determined these materials *do not* contain proprietary confidential business information. As a result, Peoples withdraws its initial Notice of Intent and the responses may be treated by the parties and the Commission as non-confidential.
