Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company (TECO or Company) requests confidential classification of certain information filed in the above-referenced docket, dated July 31, 2023.

The Company is claiming confidentiality of its filing under Section 366.093(3)(d), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (d) “[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.”

More specifically, the information at issue relates to actual purchase amounts pursuant to confidential contracts negotiated by and between the Company and certain energy providers. Furthermore, TECO requests that the information for which the Company seeks confidential classification not be declassified until 24 months after the issuance of the Commission Order disposing of this quarterly request in order to protect TECO and its customers.

Staff has reviewed the Company’s confidentiality request. It is staff’s opinion that the information subject to this request meets the criteria for confidentiality contained in Section 366.093(3)(d), F.S.
