The foregoing tariff sheet revisions are needed to recover significant, continuing increases in materials and labor costs, coupled with a decline in energy sales. The retail rate revisions described herein increase the Cooperative's total annual revenue by \$6.5 million, or 4.9%. The revised System Access Charge of \$40.00 is still below the residential rate class customer-related cost of \$47.93 per month determined in the most recent Retail Rate Study performed by the Cooperative's utility rate consultant, GDS Associates, Inc. The revised rates produce a residential customer bill for 1,000 kWh of \$146.10, which maintains our ranking as seventh highest of the sixteen electric distribution cooperatives in Florida, and is less than 4% above the average Florida cooperative customer bill of \$140.97 for 1,000 kWh.

The Cooperative is also requesting review and approval of the following original tariff sheets transmitted herewith pertaining to a new Commercial Electric Vehicle Charging Service Rate Schedule:

Rate Schedule - CEV	Original Sheet No. 10.5
Rate Schedule - CEV	Original Sheet No. 10.51

The reason for implementing Rate Schedule CEV is to promote greater electrification of the transportation sector, and specifically, the availability and utilization of electric vehicle charging

facilities in the Cooperative's service area. However, given that the electric load characteristics for commercial electric vehicle charging facilities are largely unknown, the rate schedule is applicable on an experimental basis and may be modified or discontinued by the Cooperative at any time after providing sixty days written notice.

An effective date of October 1, 2023 is requested for these revised and new tariff sheets. RATE SCHEDULE CEV

AVAILABILITY:

Availability throughout the entire territory served by the Cooperative in accordance with the Cooperative's Rules and Regulations for Electric Service.

APPLICABLE:

To electric service for the exclusive purpose of serving separately metered electric vehicle charging stations accessible to the public where the measured monthly KW demand is 1,000 KW or less. Applicability of this rate schedule for KW demands more than 1,000 KW is at the discretion of the Cooperative.

This rate schedule is experimental and may be modified or discontinued by the Cooperative at any time after providing sixty days written notice.

CHARACTER OF SERVICE:

Single phase or three phase, 60 Hertz, at one available standard voltage, at a single point of delivery.

CONDITIONS OF SERVICE:

1. Cooperative must receive documentation verifying the electric service provided herein is for qualified plug-in electric vehicle chargers, which are manufactured primarily for use on public streets, roads, and highways. Charging of electric scooters, electric bicycles, golf carts, and motorized electric wheelchairs are eligible for service under this rate schedule.
2. An audit of the facilities interconnected may occur at any time to verify that only qualified plug-in electric vehicle chargers are connected.
3. Charging stations shall be on a dedicated circuit breaker and follow all applicable codes and regulations.
4. An upfront non-refundable contribution in aid of construction is required for the installed cost of all dedicated facilities provided by the Cooperative for service hereunder.
5. Service is subject to Cooperative's Rules and Regulations for Electric Service.

2. \$1.00 per kVA of installed transformer capacity.
3. Minimum monthly charge established by contractual agreement.

TAX ADJUSTMENTS:

Amount computed at the above monthly rate, as adjusted by application of the monthly Wholesale Power Cost Adjustment, shall be subject to any applicable taxes, assessments, fees, and/or surcharges legally imposed by any governmental authority. The Florida Gross Receipts Tax on electric utility service shall be separately stated in full on all bills.

TERMS OF PAYMENT:

The above rates are net, gross rates being 5% higher on the first \$25 and 2% on the remainder of the bill. Gross rates apply if current monthly bill is not paid by due date shown on bill.

Neither rates nor bills shall be discounted, except as specifically provided in this or other rate schedules. Bills rendered hereunder are payable within the time limit specified on the bill, at Cooperative designated locations.
