Hi Dorothy,

The following CLK note accompanies the docket title of DN 20230102-SU: "Company name in application does not match name as shown in MCD; name of governmental authority in application is unclear; and cancellation or amendment of certificate is not specified in application; some contact information for City of Port St. Joe is illegible as handwritten in application."

In response to CLK's aforementioned note, please see the supporting information below to support staff's request to amend the docket title to the following: **Application for transfer of wastewater facilities to the City of Port St. Joe, and cancellation of Certificate No. 422-S, by ESAD Enterprises, Inc. d/b/a Beaches Sewer System.**

- 1) In its application, it appears the company inadvertently left out the "d/b/a" in its utility name. The company has not undergone a name change. Therefore, the appropriate name of the company is the name listed in MCD: **by ESAD Enterprises, Inc. d/b/a Beaches Sewer System**
- 2) It appears the applicant included the name of the contact person along with the governmental authority's name for part C. The governmental authority's name is: City of Port St Joe, as written. The Name, Jim Anderson, is the city manager as referenced in part D.
- 3) This Utility is a wastewater only utility that is being transferred to a governmental authority. As a result, the Utility's certificate will be cancelled since the Commission will no longer have jurisdiction over this utility. The sale of this utility to the City of Port St. Joe shall be approved as a matter of right pursuant to Section 367.071(4)(a), Florida Statutes.
