12 is to suspend the tariffs for cost recovery as  
13 staff believes we need additional time to gather  
14 pertinent information in order to present the  
15 Commission with an informed recommendation.

16 Staff will provide a final recommendation on  
17 the proposed GUARD cost recovery tariffs at the  
18 November Agenda with a proposed tariff effective  
19 date of January 1st, 2024.

20 CHAIRMAN FAY: Okay. Commissioners, any  
21 questions on Item No. 11?

22 Seeing none, we will take up a motion for Item  
23 11.

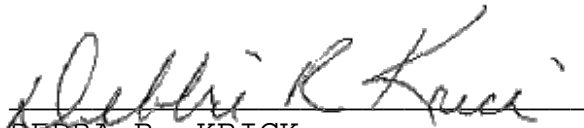
