SECTION 63.71 APPLICATION

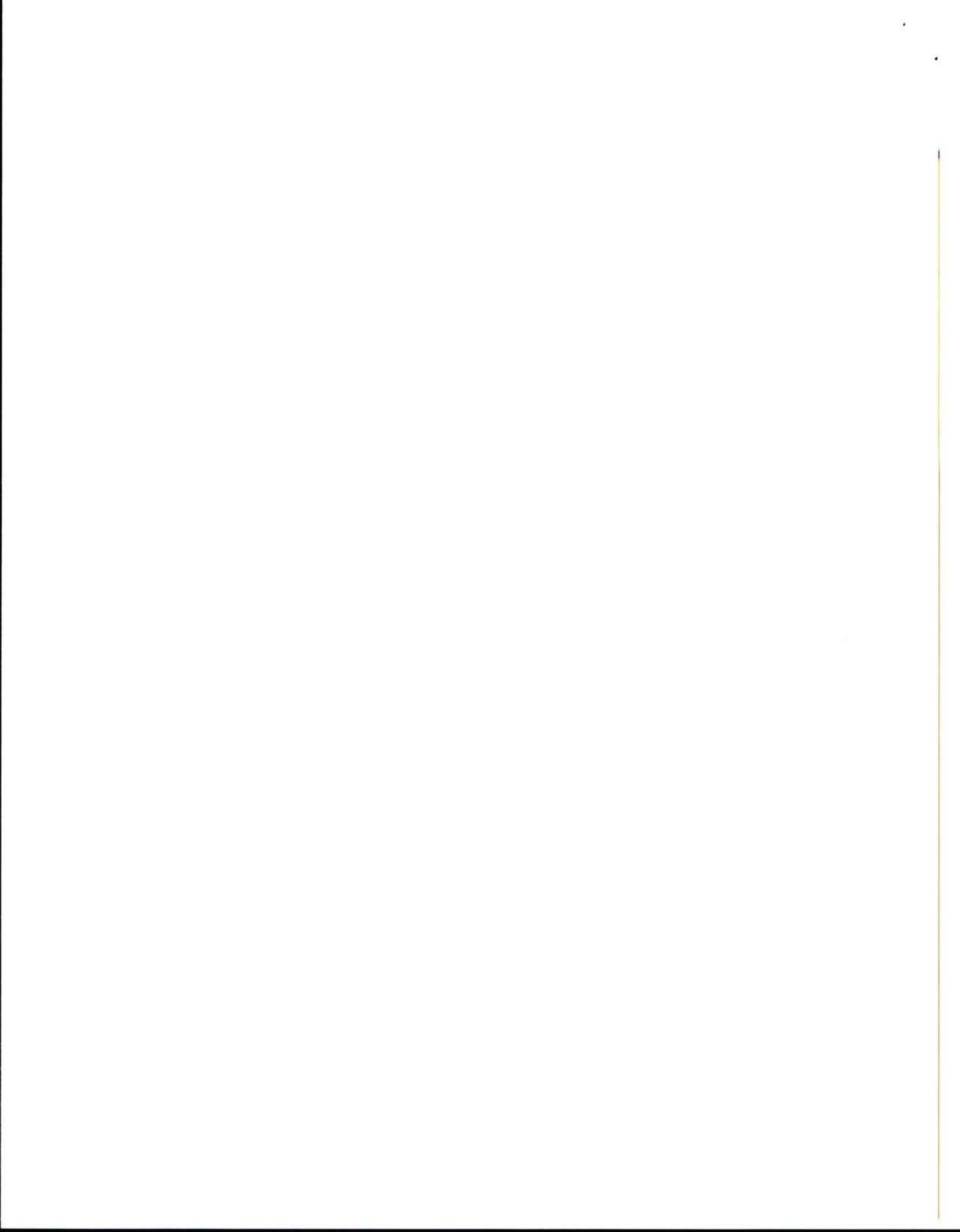
Blueface US, LLC (“Blueface” or “Applicant”), a subsidiary of Comcast Corporation (“Comcast”), hereby seeks authorization, pursuant to Section 214(a) of the Communications Act of 1934, as amended (the “Act”), 47 U.S.C. § 214(a), and Section 63.71 of the rules of the Federal Communications Commission (“FCC” or “Commission”), 47 C.F.R. § 63.71, to discontinue its offering and provision of over-the-top (“OTT”) interconnected voice over Internet protocol (“VoIP”) service and associated features. Blueface has less than eight hundred active OTT VoIP customers and maintaining the service as a standalone offering is no longer commercially viable or consistent with the company’s business plans.

Specifically, Blueface intends to stop offering OTT VoIP service to the public and to discontinue service to its remaining customers on or after February 28, 2024. The proposed discontinuance will not result in material harm to these customers, as they may obtain alternative services from Comcast or a variety of other providers, including traditional wireline providers, facilities-based VoIP providers, and non-facilities-based VoIP providers.

The Applicant provides the following information pursuant to Section 63.71 of the Commission’s rules:

- 1. Name and Address of Carrier: Blueface US, LLC, One Comcast Center, Philadelphia, PA 19103.

2. Date of Planned Service Discontinuance, Reduction, or Impairment: Blueface plans to discontinue its provision of the OTT VoIP service on or after February 28, 2024. Blueface understands that this Application will be granted automatically on the 31st day after public notice of its filing unless the Commission notifies it to the contrary.
3. Points of Geographic Areas of Service Affected: Blueface currently provides its OTT VoIP services to customers in Alabama, Arizona, California, Colorado, Connecticut, the District of Columbia, Florida, Georgia, Idaho, Illinois, Indiana, Iowa, Kansas, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina, South Dakota, Texas, Utah, Washington, Wisconsin, and Wyoming.
4. Brief Description of Type of Service Affected: As noted above, Blueface intends to discontinue its offering and provision of OTT VoIP service and associated features (e.g., call conferencing, call paging).
5. Brief Description of the Dates and Methods of Notice to All Affected Customers: In accordance with Section 63.71(a), on October 30, 2023, Blueface provided written notice by first class mail to all affected customers. A sample copy of the notice provided to customers is attached hereto as Attachment A. In addition to this formal notification, Blueface previously advised each of its customers of its plan to discontinue this service, including through an informal notice letter on October 5, 2023.



6. Whether the Carrier is Considered Dominant or Non-Dominant with Respect to the Service to be Discontinued, Reduced, or Impaired: Blueface is considered non-dominant with respect to the affected service.

In accordance with Section 63.71 of the Commission's Rules, a copy of this Application is being mailed to the Special Assistant for Telecommunications for the Secretary of Defense and to the public utility commission and the Governor of each state in which Blueface currently provides customers the OTT VoIP service subject to this application.

The public convenience and necessity will not be adversely affected by the discontinuance of the OTT VoIP service. All customers that will be affected have been given notice affording them ample time to acquire one of the many substitute services that are readily available. Blueface, therefore, respectfully requests Commission approval of this Section 63.71 Application. Please direct any questions regarding this Application to the undersigned.

We are writing to remind you that Blueface US, LLC ("Blueface"), a subsidiary of Comcast Corporation ("Comcast"), intends to discontinue its over-the-top ("OTT") interconnected voice over Internet protocol ("VoIP") services and associated features as soon as February 28, 2024. This discontinuance will impact all states that currently receive OTT VoIP services: Alabama, Arizona, California, Colorado, Connecticut, the District of Columbia, Florida, Georgia, Idaho, Illinois, Indiana, Iowa, Kansas, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina, South Dakota, Texas, Utah, Washington, Wisconsin, and Wyoming.

Please note that you are responsible for making the necessary arrangements to transition to an alternative service provided by Comcast Business or one of the many alternate service providers available in your area. Blueface will continue to provide you with reasonable support and assistance during your transition in order to minimize the potential for service disruptions. There will be no early termination fee should you decide to move your services prior to the planned Blueface shutdown.

Blueface has notified the Federal Communications Commission ("FCC" or "Commission") about its plan to discontinue these OTT VoIP services and features. The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the Commission's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the § 63.71 Application of Blueface US, LLC. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
