Our table, composed of organizations including Florida Rising, Catalyst Miami, Miami Climate Alliance, Healthy Gulf, Florida Clinicians for Climate Action, Central Florida Jobs with Justice, Earth Ethics, Food & Water Watch and the League of United Latin American Citizens urges the Public Service Commission (PSC) to facilitate direct communication between Florida Power and Light (FPL) consumers and Commissioners by hosting public hearings in the counties served by FPL before resubmitting its decision to the Supreme Court.

The previous justification submitted by the PSC in the 2021 settlement did not include the testimony offered by community members. We request that the Public Service Commission ensure that their resubmission considers the hundreds of comments provided by community members in the 2021 rate case. The concerns of community members should be acknowledged within the PSC's justification to the Supreme Court. Additionally, as the Commission considers the appropriate response to the Supreme Court's direction, we believe that the voices of those currently affected should be at the forefront of this process. This will ensure that the experiences and concerns of present-day consumers are accurately represented in the decision-making process.
