BullsEye Telecom, Inc. has requested cancellation of Certificate No. 8179, effective August 25, 2023. The certificate holder has complied with Section 364.335(3), Florida Statutes, by providing the Florida Public Service Commission notice in writing of its request for voluntary cancellation of its certificate.

Neither the cancellation of the certificate nor the failure to receive a Regulatory Assessment Fee ("RAF") return notice shall relieve BullsEye Telecom Inc. from its obligation to pay RAFs. This includes the obligation to pay any penalty and interest that may be due for the current year. Failure to pay the amounts owed to the Florida Public Service Commission will result in the Company's fees, penalties and interest being sent to a collection agency.

Pursuant to Section 2.07.C.5.f., Administrative Procedures Manual, the voluntary cancellation is acknowledged and the docket should be closed.
