McCLELLAND: Florida Public Utilities Company for approval of 6 7 its 2023 swing service rider rates, which allocates 8 a portion of the company's intrastate natural gas 9 pipeline capacity costs to transportation 10 customers. 11 The proposed swing service rider rates include 12 intrastate pipeline capacity costs, as well as 13 renewable natural gas purchased as part of a 14 short-term agreement with New River Solid Waste 15 Association, as well as gas supply software fees, 16 market data fees and legal fees. 17 The swing service rider rate is a cents per 18 therm charge that is calculated and including in 19 the monthly bill for transportation customers. 20 Staff has reviewed the proposed rates and believes 21 that they have been calculated according to the 22 original order approving the swing service tariff. 23 Staff recommends that the Commission should approve FPUC's proposed swing service rider rates 24 25 to be effective for the period January through
