Statement Regarding Financial Ability

Our Financial Strength

FPL Energy Services, Inc. ("FPLES") is a direct wholly-owned subsidiary of Florida Power & Light Company ("FPL"). Although FPLES does not publish its own financial statements, select financial information for FPLES and FPL is provided in the Consolidated Financial Statements of NextEra Energy, Inc.'s annual report or the Condensed Consolidated Financial Statements of NEE's quarterly report. As of December 31, 2022, 75 banks participate in Florida Power & Light Company's and NEECH's revolving credit facilities.

Financing

Due to our size, credit standing and available liquidity, we are one of the few companies in the energy industry that has the flexibility to initially fund the development and construction of a project using our balance sheet and not obligated to obtain external financing at these stages. Our standard approach is to utilize internally generated funds to contribute equity to the project during the construction period and then obtain limited or non-recourse financing at or after the project's commercial operation date. However, as an option, we always reserve the right to secure construction financing prior to commercial operation if market conditions are beneficial and advantageous.

The names that our company has been known by, are: NextEra Energy, Inc. (Parent company of FPL, formerly FPL Group, Inc.); FPL Group, Inc. (former name of parent company, founded in 1984); and FPL Energy Services, Inc. (founded in 1988).
