On December 21, 2023, pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida (DEF or Company) requested an extension of confidential classification for certain highlighted information contained within Duke Energy Florida's 2020 Fourth Quarter Owner's Report and Revised Exhibit D, Affidavit of Gene Flavors, Jr., as appears in Document No. 02355-2021, filed on February 22, 2020.

On February 22, 2021, DEF filed the original Request for Confidential Classification related to this document. DEF's Request was granted by Order No. PSC-2022-0239-CFO-EI on June 27, 2022.

The Company is claiming confidentiality for certain information contained within the Fourth Quarter Owner's Report, under Section 366.093(3), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsections (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information provided in the aforementioned report for which confidential treatment is being sought can be described as information revealing commercially sensitive contractual obligations related to the decommissioning of Crystal River Unit 3.

Staff has reviewed the information within the Fourth Quarter Owner's Report, as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093(3)(d) and (e), F.S. Therefore, staff recommends that the request for confidentiality of the afore-mentioned, highlighted information included in Document No. 02355-2021, be approved.
