Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) filed a first request for extension of confidential classification of certain information provided in response to the Office of Public Counsel's (OPC) first request for production of documents (POD), No. 1. FPL requests confidentiality under Section 366.093(3)(c), F.S., citing "the confidential business information includes: proprietary security measures, systems, or procedures. The disclosure of this information would cause harm to FPL and its customers."

The information for which FPL seeks confidentiality can be described as technical information about certain components of FPL's electric system. Staff has reviewed the information that FPL has filed, as well as its confidentiality request, and believes the information that is the subject of the request meets the criteria for confidentiality under the sections requested.
