Dear Mr. Johnson:

I am writing in response to the application for a staff-assisted rate case (“SARC”), which was filed on November 30, 2023, in the above-captioned docket.

On December 22, 2023, the Florida Public Service Commission (“Commission”) sent a letter via e-mail confirming that St. John's River Estates Utility, LLC was eligible for a SARC. That letter stated that the Commission must receive the \$1,200 filing fee by January 22, 2024, or the SARC application would be denied. You confirmed receipt of that letter with Commission staff on January 2, 2024.

The Office of Commission Clerk did not receive the filing fee by January 22, 2024. Pursuant to Rule 25-30.455(7), Florida Administrative Code (“F.A.C.”), this letter serves as written notification that the SARC application was denied by operation of law on that date.

You may request reconsideration of the application denial within 15 days of receipt of this letter, pursuant to Rule 25-30.455(8), F.A.C. That request would be decided by the full Commission. Or you may file a brand new application for SARC, pursuant to Rule 25-30.455, F.A.C. If a new application or a request for reconsideration are not filed by February 13, 2024, this docket will be closed.
