I am in receipt of your request to cancel certificate 8063 (Pay Telephone Service). In processing your request, it came to my attention that the name cited in the body of your letter is **Broward County**. However, our Master Commission Directory cites your name as **Broward County Board of Commissioners d/b/a Broward County Telecommunications Division**. Unfortunately, I will need a revised letter citing the name that matches what is in our records. You may send the revised letter directly to me via email or to the PSC Clerk.

In addition, our records indicate that the 2023 Regulatory Assessment Fees (RAFs) in the amount of \$100.00 have not yet been paid. Payment for the 2023 RAFs are due by January 30, 2024. Because you were certificated in 2024, you will also be responsible for 2024 RAFs which will become due in January 2025. You may pay 2024 RAFs early or when they become due in 2025.
