Request for Confidential Classification for Document No. 00975-2024

On February 29, 2024, Peninsula Pipeline Company, Inc. (Peninsula) filed a request for confidential classification for Document No. 00975-2024 for the Medley Project in Miami-Dade County. This document contains certain information in Exhibit A to its natural gas firm transportation service agreement, page 10, with Pivotal Holdings, Inc. d/b/a Florida City Gas (FCG) identifying the total maximum daily transportation quantity, the monthly reservation charge, and the unauthorized use rate. Staff reviewed the document and concurs with Peninsula that the nature of the information meets the requirements set forth in Sections 366.093(3) (d) and (e), Florida Statutes (F.S.), whereby disclosure of the information would harm the competitive business operations of Peninsula.

Therefore, staff recommends that the request by Peninsula for confidential classification of Document No. 00975-2024 be approved.
