

FAR NOTICE OF PREHEARING CONFERENCE AND HEARING

PUBLIC SERVICE COMMISSION

The FLORIDA PUBLIC SERVICE COMMISSION announces a prehearing conference and a hearing in the following docket to which all persons are invited.

DOCKET NO. AND TITLE: 20240001-EI – Fuel and purchased power cost recovery clause with generating performance incentive factor.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE PREHEARING:

The purpose of this prehearing conference is to: (1) simplify the issues; (2) identify the positions of the parties on the issues; (3) consider the possibility of obtaining admissions of fact and of documents which will avoid unnecessary proof; (4) identify exhibits; (5) establish an order of witnesses; and (6) consider such other matters as may aid in the disposition of the action.

HEARING DATE AND TIME: Tuesday, March 26, 2024, immediately following the 9:30 a.m. (EST) Commission Internal Affairs Meeting. March 27, 2024, has also been reserved for continuation of the hearing, if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purpose of this hearing is to determine the prudence and potential replacement power cost recovery associated with Florida Power and Light Company's actions, or failures to act, resulting in unplanned nuclear power outages that occurred during 2020, 2021, and 2022.

The purpose of this hearing is also to consider any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. Interested persons may request to be listed as an interested person for these dockets, in which case they will receive notices and orders published and issued in these dockets.
