# TAMPA ELECTRIC COMPANY'S NOTICE OF WITHDRAWAL OF FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION

Tampa Electric Company ("Tampa Electric" or "the company"), pursuant to Section 366.093, Florida Statutes ("F.S."), and rule 25-22.006, Florida Administrative Code, submits this Notice of Withdrawal of its First Request for Extension of Confidential Classification, filed on April 9, 2024. In support of this Request, Tampa Electric states:

- 1. On April 9, 2024, Tampa Electric filed a First Request for Extension of Confidential Classification for certain information provided in its answers to the Office of Public Counsel's ("OPC") Second Set of Interrogatories (Nos. 34-37) and responses to Second Request for Production (Nos. 2-3), filed on June 20, 2022. *See* DN 01722-2024.
- 2. Since that time, the Commission Clerk's office informed Tampa Electric that the documents in question were returned to Tampa Electric on April 28, 2023. As a result, no extension of confidential classification is necessary, and Tampa Electric hereby withdraws its First Request for Extension for these documents.
