NOTICE OF WITHDRAWAL OF
FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION**

Tampa Electric Company (“Tampa Electric” or “the company”), pursuant to Section 366.093, Florida Statutes (“F.S.”), and rule 25-22.006, Florida Administrative Code, submits this Notice of Withdrawal of its First Request for Extension of Confidential Classification, filed on April 9, 2024. In support of this Request, Tampa Electric states:

1. On April 9, 2024, Tampa Electric filed a First Request for Extension of Confidential Classification for certain information provided in its answers to the Office of Public Counsel’s (“OPC”) Second Set of Interrogatories (Nos. 34-37) and responses to Second Request for Production (Nos. 2-3), filed on June 20, 2022. *See* DN 01722-2024.

2. Since that time, the Commission Clerk’s office informed Tampa Electric that the documents in question were returned to Tampa Electric on April 28, 2023. As a result, no extension of confidential classification is necessary, and Tampa Electric hereby withdraws its First Request for Extension for these documents.


