FLORIDA RISING’S & LEAGUE OF UNITED LATIN AMERICAN CITIZENS’ NOTICE OF JOINDER IN CITIZENS’ EXPEDITED MOTION FOR RECONSIDERATION OR, IN THE ALTERNATIVE, MOTION FOR CONTINUANCE

Florida Rising and League of United Latin American Citizens of Florida (“LULAC”), by and through undersigned counsel, hereby join in the Citizens of the State of Florida’s Motion for Reconsideration of Order No. PSC-2024-0092-PCO-EI, issued on April 11, 2024, and Order No. PSC-0092-PCO-EI, issued on April 16, 2024, or, in the alternative to continue the hearing and corresponding key activity dates. Florida Rising and LULAC are parties in docket number 20240025-EI and have pending petitions to intervene in docket number 20240026-EI,¹ and have a vested interest in the relief request by the Citizens of the State of Florida on the issues presented, and thus join the motion in full. Florida Rising and LULAC note that in addition to all of the time constraints faced by Citizens of the State of Florida, Florida Rising and LULAC also need to wait for their intervention to be granted in order to file enforceable discovery. Although both Duke Energy Florida and Tampa Electric Company agreed to accept discovery from Florida Rising and LULAC in these cases, until intervention was granted in Duke Energy Florida’s case (and is still pending in Tampa Electric Company’s case as of the time of this filing), Florida Rising and LULAC had no mechanism to enforce their discovery requests.

¹ Florida Rising’s and LULAC’s unopposed Petition to Intervene in docket number 20240026-EI has now been pending for 47 days.
