**FLORIDA RISING’S & LEAGUE OF UNITED LATIN AMERICAN CITIZENS’
REQUEST FOR ORAL ARGUMENT ON MOTION FOR
RECONSIDERATION OF ORDER DENYING ORLANDO-AREA SERVICE HEARING**

Florida Rising and League of United Latin American Citizens of Florida (“LULAC”), pursuant to Rule 25-22.0022, Florida Administrative Code, request that the Florida Public Service Commission allow oral argument on Florida Rising’s and LULAC’s Motion for Reconsideration of Order Denying Orlando-Area Service Hearing, filed on May 17, 2024.
