### PURPOSE AND PROCEDURE

The purpose of the customer service hearings is to give customers and other interested persons an opportunity to offer comments regarding the quality of service the utility provides, the proposed rate increase, and to ask questions and comment on other issues. One or more of the Commissioners of the FPSC may attend and participate in this hearing.

The procedure at these hearings shall be as follows: Tampa Electric Company will present a brief summary of its case and then members of the public may present testimony. Members of the public who wish to present testimony are urged to appear promptly at each scheduled hearing time since the hearing may be adjourned early if no witnesses are present to

testify. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
