Below is a breakdown of the RAF amounts due and payment information for SQF, LLC with regard to 2023 RAFs.

DATE	ACTION
January 30, 2024:	Minimum 2023 RAFs of \$600.00 due.
January 31, 2024:	5% late penalty and 1% interest assessed to outstanding RAF due. Total owed = \$600.00 RAF + \$30 penalty + \$6 interest = \$636.00
March 1, 2024:	Additional 5% late penalty and 1% interest assessed to outstanding RAF due. Total owed = \$600.00 RAF + \$60 penalty + \$12 interest = \$672.00
March 31, 2024	Additional 5% late penalty and 1% interest assessed to outstanding RAF due. Total owed = \$600.00 RAF + \$90 penalty + \$18 interest = \$708.00
April 18, 2024:	Payment received in the amount of \$100.00. This amount was deducted from the RAF amount owed. Total owed = \$500.00 RAF + \$90 penalty + \$18 interest = \$608.00
April 30, 2024	Additional 5% late penalty and 1% interest assessed to outstanding RAF due. Total owed = \$500.00 RAF + \$115.00 penalty + \$23.00 interest = \$638.00
May 2, 2024:	Payment received in the amount of \$608.00. This payment satisfied the outstanding RAF and partially satisfied penalty and interest. Total owed = \$0.00 RAF + \$7.00 penalty + \$23.00 interest = \$30.00

At this time, SQF owes \$30.00 to satisfy the Company's 2023 RAFs, penalty and interest. However, pursuant to our earlier conversations, on April 22, 2024, a 2nd RAF violation non-compliance docket was opened. I've attached the PAA Order which explains the 2nd non-compliance docket and the associated penalty of \$1,000.00.

In conclusion, in order to retain the local exchange certificate, SQF needs to remit the \$1,000.00 RAF noncompliance penalty in addition to the \$30.00 still owed in RAF penalty and interest, for a total of **\$1,030.00**, prior to the issuance of a consummating order, which is scheduled for **May 30, 2024**. If SQF fails to pay this amount prior to the issuance of the consummating order, its certificate will be cancelled administratively.
