On May 16, 2024, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 03245-2024. This document contains confidential information from a response to Sierra Club's First Set of Interrogatories, Nos. 25a - 25c, 29, 30c and 30d. The confidential information contained within the responses can be described as capacity payment amounts, capacity cost amounts and purchase power agreement payment amounts.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 03245-2024 as private and has not publicly disclosed it. If disclosed it may impair the competitive business of the provider of the information.

Staff has reviewed the documents and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair the competitive business interests. Therefore, staff recommends the request by TECO for confidential classification of Document No. 03245-2024 be approved.
