On June 18, 2024, Peninsula Pipeline Company, Inc. (Peninsula) and Florida Public Utilities Company (FPUC), jointly the parties, filed a request for confidential classification for Document No. 06693-2024. This document consists of Attachments B and C to the companies' joint responses to staff's first data request. The document contains certain information identifying the minimum annual transportation quantity, total maximum daily transportation quantity, and construction costs. The parties state that they treat the redacted information provided in Document No. 06693-2024 as confidential. Staff reviewed the document and concurs with the parties that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of Peninsula and FPUC. Therefore, staff recommends that the request by the parties for confidential classification of Document No. 06693-2024 be approved.
