Pursuant to Section 366.093(3)(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC ("DEF") requests confidential classification of certain information and documents provided in response to Sierra Club's 4th request for PODs (Nos. 22-25), Item No. 23. The document number for the confidential filing is 03939-2024, and the document number for the request for confidential classification is 05254-2024.

DEF's response to POD No. 23 consists of sensitive project documents, including pricing information for goods and service, related to a construction project at a generating facility. DEF asserts that the data is proprietary, and public disclosure would impair it in the marketplace.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Section 366.093(3)(d), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 03939-2024 be approved.
