On June 7, 2024, Duke Energy Florida (DEF or Company) filed a request for confidential treatment of Document No. 06236-2024. This document contains confidential information provided in a late-filed exhibit regarding the depositions of witness Benjamin Borsch and witness Hans Jacob held on May 30, 2024, and May 29, 2024, respectively. The confidential information contained within the response can be described as information related to planned outages, specific unit must-run assumptions and technology selection criteria for proposed battery storage projects.

In its request for confidentiality, DEF asserts that disclosure of this information would harm DEF, as the information relates to contractual data and competitive interests. Furthermore, DEF states that the Company treats the highlighted information provided in Document No. 06236-2024 as private and has not publicly disclosed it. If disclosed it may impair the Company's ability to contract for goods and services on favorable terms and also impair the competitive business of the provider of the information.

Staff has reviewed the documents and concurs with DEF that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would impair DEF's ability to contract for goods or services, and impair the competitive business interests. Therefore, staff recommends the request by DEF for confidential classification of Document No. 06236-2024 be approved.
