On June 20, 2024, Duke Energy Florida (DEF or Company) filed a request for confidential treatment of Document No. 04458-2024. This document contains confidential information from a response to FL Rising and League of United Latin American Citizens of Florida's First Request for Production of Documents, No 1. The confidential information contained within the response can be described as financial information from third party partners used by the company in calculations for cost-effectiveness in the Company's DSM plans.

In its request for confidentiality, DEF asserts that disclosure of this information would harm DEF, as the information relates to competitive interests. Furthermore, DEF states that the Company treats the highlighted information provided in Document No. 04458-2024 as private and has not publicly disclosed it.

Staff has reviewed the documents and concurs with DEF that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair DEF's competitive business interests. Therefore, staff recommends the request by DEF for confidential classification of Document No. 04458-2024 be approved.
