On June 6, 2024, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 05086-2024. This document contains confidential information contained in the direct testimony of TECO witness Jonathan Ly. The confidential information contained within the testimony can be described as projected carbon emission costs, implementation dates, and escalation rates that were derived from the work of a third party consultants proprietary work.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 05086-2024 as private and has not publicly disclosed it.

Staff has reviewed the documents and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair the competitive business interests of the third party consultant. Therefore, staff recommends the request by TECO for confidential classification of Document No. 05086-2024 be approved.
