Pursuant to the Federal Communications Commission's (FCC) 15-70 Order¹, allowing interconnected VoIP providers to obtain resources directly from the North American Numbering Plan Administrator and/or the Pooling Administrator, we hereby notify the Commission of our receipt of FCC numbering authorization².
