Pursuant to Section 366.093 of the Florida Statutes (F.S), and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC. (DEF or Company) requests confidential classification of certain information that was provided on July 1, 2024, in response to Staff's First Request for Production of Documents (PODs), Nos. 1 - 9, specifically POD No. 6, issued in the above docket, which relates to DEF's employment forecasts. This document (DN 07098-2024) replaces previously filed defective CD in confidential DN 02854-2024.

DEF is claiming confidentiality of certain information contained in its response to Staff's First Request for PODs, Nos. 1 - 9, specifically POD No. 6, under Section 366.093(3)(e), F.S. Per the statute, propriety of confidential business information includes, but is not limited to "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information provided in the Company's response contains sensitive competitive business information pertaining to DEF's employment forecasts which are proprietary and the disclosure of which would impair the competitive business of the provider/owner of the information.

Staff has reviewed the information provided in DEF's response to Staff's First Request for PODs, Nos. 1 - 9, specifically POD No. 6, as well as the Company's confidentiality request (DN 04317-2024). In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093 F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 07098-2024 be approved.
