On August 1, 2024, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 08178-2024. This document contains confidential portions of the July 22, 2024 deposition transcript of witness Carlos Aldazabal. The confidential information contained within the document can be described as questions and answers about the confidential document number 07514-2024, filed on July 12, 2024, in Docket No. 20240026-EI, which is lease information concerning the MacDill Air Force Base.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to contractual data and competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 08178-2024 as private and has not publicly disclosed it.

Staff has reviewed the document and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(d),(e), Florida Statutes, whereby disclosure of the information would impair the efforts of the TECO to contract for goods or services on favorable terms and impair the competitive business interests. Therefore, staff recommends the request by TECO for confidential classification of Document No. 08178-2024 be approved.
