2 CHAIRMAN LA ROSA: Good morning, everybody.  
3 If you don't mind joining Commissioner Graham and  
4 us with the Pledge and the Invocation.

5 (Invocation and Pledge of Allegiance.)

6 CHAIRMAN LA ROSA: Excellent. Well, welcome.  
7 Today is August 8th. We are here to call the  
8 August 6th Agenda to order.

9 Today's schedule, we are going to take up Item  
10 1 and 3 and then 5 and 7 in the move staff process,  
11 and then we will talk about Item 4 towards the end  
12 of today's Agenda.

13 Let's go ahead -- I think we are ready, so  
14 let's go ahead and move to Item No. 1.

15 Ms. Gatlin, you are recognized when you are  
16 ready.

17 MS. GATLIN: Good morning, Chairman and  
18 Commissioners. I am Cassie Gatlin with the  
19 Division of Accounting & Finance.

20 Item 1 is staff's recommendation addressing  
21 the remaining issues of Duke Energy Florida, LLC's,  
22 petition for recovery of incremental storm  
23 restoration costs related to Hurricanes Elsa, Eta,  
24 Isaias, Ian, Nicole and Tropical Storm Fred, as  
25 well as to replenish a storm reserve.

1           Administrative hearing was held on May 21st,  
2           2024. At that hearing, the Commission approved  
3           stipulations on Issues 1 through 15, 18 and 19,  
4           resulting in an approved total retail recoverable  
5           storm cost of 431.3 million plus interest.

6           The only two remaining issues to be voted on  
7           today are Issues 16 and 17. These issues it  
8           address the method of recovering costs from  
9           demand-metered customers, and the method of  
10          handling any over- or under-recovery of storm  
11          restoration cost. There was an oral modification  
12          to this recommendation. Your offices have received  
13          this modification.

14          This is a post-hearing decision with  
15          participation limited to Commissioners and staff.  
16          Staff is available for any questions.

17          Thank you.

18          CHAIRMAN LA ROSA: Commissioners, are there  
19          questions or discussions? Questions or  
20          discussions?

21          If not, is there a motion.

22          COMMISSIONER CLARK: Move approval of the  
23          item, Mr. Chairman.
