PEOPLES GAS SYSTEM'S PRELIMINARY LIST OF ISSUES AND POSITIONS

Peoples Gas System, Inc. ("PGS"), by its undersigned attorneys, submits the following Preliminary

List of Issues and Positions:

Generic Purchased Gas Adjustment Issues

<u>ISSUE 1</u>: What are the final purchased gas adjustment true-up amounts for the period January 2023 through December 2023?

<u>PGS</u>: \$2,061,348 over-recovery.

<u>ISSUE 2</u>: What are the appropriate purchased gas adjustment actual/estimated true-up amounts for the period January 2024 through December 2024?

<u>PGS</u>: \$345,340 over-recovery.

- **<u>ISSUE 3</u>**: What are the total purchased gas adjustment true-up amounts to be collected during the period from January 2025 through December 2025?
 - <u>PGS</u>: An over-recovery of \$2,406,687 to be refunded to customers.
- **<u>ISSUE 4</u>**: What are the levelized purchased gas adjustment cost recovery (cap) factors (\$0.000 per therm) for the period January 2025 through December 2025?

<u>PGS</u>: \$1.00135 per therm.

<u>ISSUE 5:</u> What should be the effective date of the new purchased gas adjustment cost recovery (cap) factors for billing purposes be?

<u>PGS</u>: The new purchased gas adjustment charge should be effective beginning with the specified purchased gas cost recovery cycle and thereafter for the period January 2025 through December 2025. Billing cycles may start before January 1, 2025, and the last cycle may be read after December 31, 2025, so that each customer is billed for 12 months, regardless of when the factor became effective.

ISSUE 6: Should the Commission approve revised tariffs reflecting the new purchased gas adjustment cost recovery (cap) factors determined to be appropriate in this proceeding?

<u>PGS</u>: Yes. The Commission should approve revised tariffs reflecting the new purchased gas adjustment charges determined to be appropriate in this proceeding. The Commission should direct staff to verify that the revised tariffs are consistent with the Commission's decision.

ISSUE 7: Should this docket be closed?

<u>PGS</u>: Yes. Docket No. 20240003-GU should be closed once the Commission's decisions on all the issues in the docket have become final and the Commission has concluded that the docket has otherwise met the requirements for closure.
