BARR TELL USA INC. PLANNED RESOURCE ORDERING AS TO CHANGES AND THE FUTURE ORDERING OF RATE CENTERS & THOUSANDS BLOCKS

This Note explains the submission of the 30 day Notification, pursuant to the FCC 15-70 Order, allowing interconnected VOIP providers to obtain resources directly from the North American Numbering Plan Administrator and/or the Pooling Administrator

Although Barr Tell USA is an established Facilities based CLEC and already has telephone numbering resources in two Florida LATAs it will begin to convert the Code and blocks in LATA 460 from TDM into VOIP.

Unfortunately, Barr Tell cannot afford to support and pay for a physical TDM trunk group that is only one way, terminating traffic into Barr Tell's network. The now existing trunk allows AT&T to send their local and intraLATA voice traffic to Barr Tell's customers at Barr Tell's expense. By converting the existing LATA 460 trunk to VOIP, Barr Tell can utilize its switching partner's existing trunk and eliminate this monthly expense.

In the LATA 952, where Barr Tell is physically connected to Frontier Communications with TDM (and Verizon before that) this problem does not exist and no changes need take place.

In the remaining LATAs: 450, 452, 454, 456, 458, 939 and 953 where Barr Tell does not have numbering resources it would start by ordering a single code in each of the LATAs for an LRN.

From each of these new codes, Barr Tell USA will return 9 blocks in each code back to the Pooling Administration and keep only one block. This will provide Barr Tell USA with enough one thousand block resources to start.

Since Barr Tell USA's main business provides telephone services to only Business customers for expansion Barr Tell will order its rate center numbering resources beginning in the largest populated cities within each of these LATAs as individual, single blocks are needed.
