Subject: Docket 20240026, Fuel Retailers Stipulation

The Fuel Retailers have reached a stipulation with Tampa Electric regarding the Tampa Electric EV charging pilot. While this stipulation does not address one of the identified issues in the case on the prehearing order, it is relevant to the Fuel Retailers' participation in the case.

The stipulation is:

Tampa Electric is not requesting approval for any changes to its current electric vehicle charging pilot program in this case, and will not otherwise seek to expand or increase its electric vehicle charging pilot program approved in Order Nos. PSC-2021-0144-PAA-EI and PSC-2021-0175-CO-EI, issued in Docket No. 20200220-EI, other than changes permitted by Section 366.94(4) of the Florida Statutes.

If the parties have no objection or take no position, upon approval by the Commission, the Fuel Retailers would waive opening, waive cross, and otherwise request to be excused from the hearing. The Fuel Retailers would remain a party of record.

If you have an objection or concern, please let us know. Otherwise, I will request that this be taken up as one of the preliminary matters for the hearing today.
