PURPOSE AND PROCEDURE:

The purpose of this hearing is to consider the petitions of Duke Energy Florida, LLC, Florida Power & Light Company, Florida Public Utilities Company, and Tampa Electric Company for in Docket No. 20240010-EI - Storm protection plan cost recovery clause and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on September 9, 2024. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

This hearing will be governed by Chapters 120 and 366, F.S., and Chapters 25-22, and 28-106, Florida Administrative Code.
